Dear Mr. Marc Mason:

The following amendment, submitted in connection with registration under section 3(c)(7)(A) of the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), as amended, is acceptable:

- Revise Precautionary Statements
- Include Disposal Statements
- Update First Aid Statements
- Label language update

# Conditions

Revise the label as follows:

A. Based on the "cite-all" method of support, revise the "Precautionary Statements" to read exactly as follows:

"Corrosive. Causes irreversible eye damage and skin burns. May be fatal if inhaled. Harmful if swallowed or absorbed through the skin. Do not get in eyes, on skin, or on clothing. Do not breathe vapor or spray mist. Wear a dust/mist filtering respirator (MSHA/NIOSH approval number prefix TC-21C), or a NIOSH approved respirator with any N, R, P or HE filter. Wear goggles or face shield, rubber gloves and protective clothing when handling. Prolonged or frequent skin contact may cause allergic reactions in some individuals.

Wash thoroughly with soap and water after handling. Remove contaminated clothing and wash before reuse."

B. Revise the "First Aid" statements to include:

"IF INHALED: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably mouth-to mouth if possible. Call a poison control center or doctor for further treatment advice."

C. Add the following statement to the middle panel of the label:

"For Formulation into Antimicrobial Products"

D. Revise the "Container Disposal" section by deleting the statements beginning: "In addition, plastic containers..." and ending "If burned, stay out of smoke."

# **General Comments**

Revise your technical information bulletin such that it is in agreement with the label comments above.

A stamped copy of the accepted labeling is enclosed. Submit one (1) copy of your final printed labeling before distributing or selling the product bearing the revised labeling.

Submit and/or cite all data required for registration/reregistration of your product under FIFRA section 3(c)(5) and section 4(a) when the Agency requires all registrants of similar products to submit such data.

If the above conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6(e). Your release for shipment of the product bearing the amended labeling constitutes acceptance of these conditions.
