3. Submit five (5) copies of your final printed labeling before you release the product for shipment. Refer to the A-79 enclosure for a further description of final printed labeling.



**INITIAL APPLICATION FOR SWIMMING POOLS
(To A Clean Pool)**

Two gallon MAQUAT MC1412-5% to each 50,000 gallons of water or ratio thereof. If Algae growth is visible apply the initial dose. Vacuum pool after 24 hours to remove dead algae. If algae is still visible repeat dose as necessary until pool is free of visible algae.

CONTINUED APPLICATION

Two quart MC1412-5% in 50,000 gallons of water every 3-5 days or as needed to maintain 2 ppm active. Quaternary Test Kits are available for this use.

BOOSTER APPLICATION

Two quart MC1412-5% in 50,000 gallons after a heavy or prolonged rainfall or when there is a heavy bathing load.

The above directions should be followed even when the pool is not in use.

If algae growth is noticeable, apply the initial dose.
