

The amendment referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act, will be acceptable provided that you make the labeling changes listed below before you release the product for shipping bearing the amended label.

- Under the Statement of Practical Treatment, remove egg whites and gelatin solution, revise statement to read "If swallowed, drink promptly a large quantity of water."
- 2. Under the heading "Disinfection", revise the statement ...hard inanimate surfaces..., to read, hard, non-porous, inanimate surfaces....
- 3. Revise disclaimer statement to conform with the wording in PR-Notice 94-4 to read "This product is not to be used as a terminal sterilant/high level disinfectant on any surface or instrument that (1) is introduced directly into the human body, either into or in contact with the bloodstream or normally sterile areas of the body, or (2) contacts intact mucous membranes but which does not ordinarily penetrate the blood barrier or otherwise enter normally sterile areas of the body. This product may be used to preclean or decontaminate critical or semi-critical medical devices prior to sterilization or high level disinfection".

This product is a heavy duty cleaner and disinfectant for schools, motels, offices, kitchens, food processing plants and light industrial and hospital applications where heavy duty cleaning is of prime importance. When used as directed it is formulated to disinfect manimate hard surfaces (such as walls, floors, sink tops, toilet bowls, tables, chairs, and telephones). For larger areas, such as patient care facilities and restrooms, the product is designed to provide both heavy duty cleaning and disinfecting. It is designed to aid in controlling the hazard of cross contamination in areas where heavy duty cleaning is necessary.

When used as directed it will remove most household dirt in a single, simple operation. In addition, this product deodorizes those areas which generally are hard to keep fresh smelling, such as garbage storage areas, empty garbage bins and cans, toilet bowls and any other areas which are prone to odors caused by microorganisms.

DISINFECTION - At 4.5 ounces per gallon dilution, this product exhibits effective disinfectant activity against the organisms: Escherichia coli, Salmonella choleraesuis, staphvococcus aureus...At this level the product is also fungicidal against the pathogenic fungi, Trichophyton mentagrophytes ... At 6 ounces per gallon dilution this product is an effective hospital disinfectant and demonstrates disinfectant activity against Pseudomonas neruginosa. Efficacy tests have demonstrated that it is an effective bactericide, and fungicide, in the presence of organic soil (5% blood serum).

MOLD AND MILDEWSTAT - This product controls mold and mildew and the odors they cause on nard non-porous inanimate surfaces at 4.5 minces per gallon dilution.

#### DIRECTIONS FOR USE

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling. This product is not to be used on any surface or instrument that (1) is introduced directly into the human body, either into or in contact with the bloodstream or normally sterile areas of the body, or (2) contacts intact mucous membranes but which does not ordinarily penetrate the blood barrier or otherwise enter normally sterile areas of the body.

This detergent/disinfectant has been designed specifically for hospitals, offices, motels, nursing homes, schools, food processing plants, and other institutions where housekeeping is of prime importance.

DISINFECTION - To disinfect hard inanimate surfaces (such as wails, floors, table tops), apply solution with mop, cloth sponge or mechanical sprayer so as to wet all surfaces thoroughly. Allow to remain wet for 10 minutes and then let air dry.

DILUTION RATES: For general cleaning and deodorizing use 2 ounces per gallon of water...For general disinfection add 4.5 ounces per gallon of water... For hospital disinfection add 6 ounces per gation of water ... To disinfect toilet bowls, flush toilet, add 4.5 ounces detergent/disinfectant directly to the bowl water. solution with a cloth, mop or sponge making sure to wet all surfaces completely. Let air dry. Prepare a fresh solution for each use. Repeat application at weekly intervals or when mildew growth reappears.

#### STORAGE AND DISPOSAL
