Dear Mr. Marc Mason:

The following amendment, submitted in connection with registration under section 3(c)(7)(A) of the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), as amended, is acceptable with the conditions listed below.

- Revise Precautionary Statements
- Update Disposal Statements
- Update First Aid Statements

Conditions

Revise the label as follows:

1. Based on the data which is currently available for this active ingredient, revise the "Precautionary Statements" to read exactly as follows:

"Corrosive. Causes irreversible eye damage and skin burns. May be fatal if inhaled or absorbed through the skin. Harmful if swallowed. Do not get in eyes, on skin, or on clothing. Do not breathe vapor or spray mist. Wear a dust/mist filtering respirator (MSHA/NIOSH approval number prefix TC-21C), or a NIOSH approved respirator with any N, R, P or HE filter. Wear goggles or face shield, rubber gloves and protective clothing when

handling. Wash thoroughly with soap and water after handling *and before eating, drinking, or using tobacco*. Remove contaminated clothing and wash before reuse.”

2. Delete the following sites from your Directions for Use. According to the Agency records the following sites are not approved for this active ingredient: dairy farm milk handling facilities, equipment, storage rooms, houses and sheds, pulp/paper mill water systems, and mushroom houses/empty premise equipment.

3. Delete these additional sites from your Directions for Use. According to the Agency records these sites are currently not supported for this active ingredient: wood preservation and egg washing treatment.

4. Submit a revised Certification With Respect to Citation of Data Form. The submitted form does not correctly identify the general use patterns for this product. Revise to state “Indoor and Outdoor.” Also include the PC code for the active ingredient in this product: 069141.


A stamped copy of the accepted labeling is enclosed. Submit one (1) copy of your final printed labeling before distributing or selling the product bearing the revised labeling.

Submit and/or cite all data required for registration/reregistration of your product under FIFRA section 3(c)(5) and section 4(a) when the Agency requires all registrants of similar products to submit such data.

If the above conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6(e). Your release for shipment of the product bearing the amended labeling constitutes acceptance of these conditions.

For formulation into antimicrobial products for use in agricultural/farm premises, structures, buildings, and equipment; dairy farm milk handling facilities, equipment, storage rooms, houses and sheds; food processing plant, food handling, food distribution equipment and premises; eating establishment premises and equipment; commercial, institutional, and industrial premises and equipment (floors, walls, storage areas); domestic dwellings, food handling areas, bathroom premises (hard surfaces), indoor premises and medical institutional critical care and noncritical premises and laundry. For formulation into antimicrobial products for use in air conditioner/refrigeration condensate water systems, air washer and industrial scrubbing systems, once-through and recirculating industrial/commercial cooling water systems, pulp/paper mill water systems, and swimming pools. Gas/oil drilling muds/packer fluids, mushroom houses/empty premises equipment, wood preservative, egg handling equipment and rooms, egg washing treatment poultry processing plant equipment/ premises, meat processing plant/equipment, gas oil recovery injection water systems.

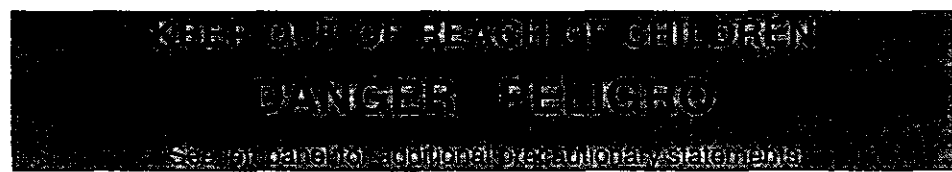

First Aid
