The following amendment, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA) Section 3(c)7(a), as amended, is acceptable subject to the conditions listed below:

### **Proposed Amendments**

- Revise Storage and Disposal Section
- Add additional language

### Revise the label as follows:

- 1. Revise the label to provide clarity by deleting the word "only" such that the text on page 1 reads: "For Manufacturing Use".
- 2. Revise the Precautionary Statements to include the following expanded "Wash thoroughly..." statement as per the Label Review Manual. Revise to include: "Wash thoroughly with soap and water after handling and before eating, drinking, chewing gum, using tobacco or using the toilet."
- 3. Revise the Environmental Hazards statement to be in agreement with the ADBAC RED by including the following statement: "This product is toxic to fish, aquatic invertebrates, oysters and shrimp. Do not discharge effluent containing this product into lakes, streams..."
- 4. Delete the "Triple rinse or equivalent." statement from the refillable container disposal section on page 2. This information contradicts the information which follows in the Residue Removal Instructions.
