#### **Hepatitis Virus**

At  $\frac{1}{2}$  ounce of this product per gallon of water (or equivalent use dilution) in the presence of 400 ppm hard water (CaCO<sub>3</sub>) and 5% serum this product was proven to be effective against Hepatitis B and Hepatitis C Virus with a contact time of 10 minutes.
