3. Make the following revisions to the label.

A. Based on your method of data support for this product, this product is classified in the following Toxicity categories: Primary Eye I, Primary Skin I, Acute Inhalation II, Acute Oral III, Acute Dermal III and as a non-sensitizer. Revise your "Precautionary Statements" by deleting the statement: "May be fatal if swallowed." and change the text to read: "Harmful if absorbed through skin or swallowed."

B. Revise your Container Disposal statement by deleting the following language: "by other procedures approved by state and local authorities. In addition, plastic containers may be disposed of by".

C. Add the following phrase to the right panel of the label: "For Formulation into Antimicrobial Products".

D. The Agency has revised your "Formulator's Exemption Statement" by correcting the date of the submitted Confidential Statement of Formula to read: 11/4/02. Make this same correction to the form in your files.

4. Submit a revised Confidential Statement of Formula (CSF). Check with your supplier for the correct pH and flash point. The information on the CSF dated 11/4/02 does not agree with your source.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA sec. 6(e). Your release for shipment of the product constitutes acceptance of these conditions.

A stamped copy of the label and technical bulletin is enclosed for your records. Submit one (1) copy of the final printed label prior to the release of the product for shipment.

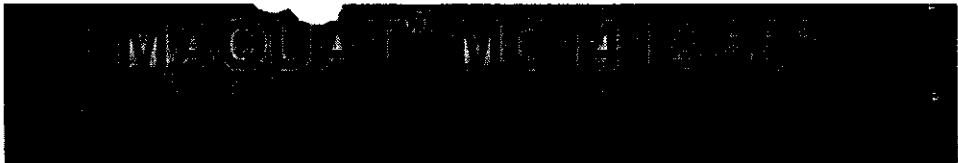

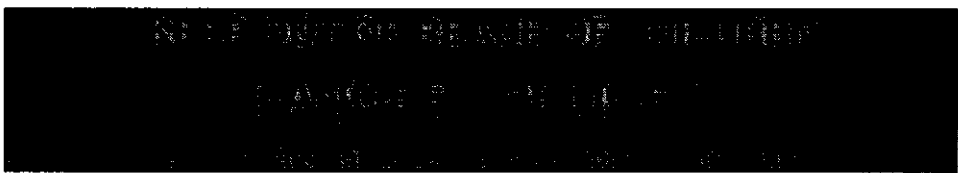

First Aid
