

**PRECAUTIONARY STATEMENTS

DANGER!**

Corrosive. Causes severe eye injury and skin irritation. Do not get in eyes, on skin or on clothing. Remove and wash contaminated clothing before reuse. Wear goggles or face shield and rubber gloves when handling. Harmful if swallowed. See front panel for statement of practical treatment.

ENVIRONMENTAL HAZARDS

This product is toxic to fish. PHYSICAL OR CHEMICAL HAZARDS

STATEMENT OF PRACTICAL TREATMENT

GENERAL CLASSIFICATION**

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

For control of bacteria in oil field, waterflood, or saltwater disposal systems.

VISCO 3990 may be fed intermittently at a rate of 50-100 ppm (5-20 gallons per 2400 barrels of water) for 1-2 hours a day, 1-4 times a week, or as needed to maintain control. VISCO 3990 may also be fed continuously at a rate of 50-200 ppm until the desired degree of control is achieved. Follow up with 10-25 ppm VISCO 3990 (1-2.5 gallons per 2400 barrels of water) continuous feed to maintain control. Feed VISCO 3990 directly from the drum through any chemical pump.
