    We note with regret the fact that our letter of February 11, 1985, omitted the above sentence.
- Submit five (5) copies of your final printed labeling before you release the product for shipment.

#### STATEMENT OF PRACTICAL TREATMENT

In case of contact, immediately flush eyes with plenty of water for at least 15 minutes. Call a physician. Wash skin with soap and water. Remove contaminated clothing and wash before reuse. Discard contaminated shoes.

If swallowed, drink promptly a large quantity of milk, egg whites, gelatin solution or if these are not available, drink large quantities of water. Avoid alcohol. Call a physician at once. Never give an unconscious person anything by mouth.

NOTE TO PHYSICIAN: Probably, mucosal damage may contraindicate the use of gastric lavage. Measures against circulatory shock, respiratory depression and convulsions may be needed.
