The labeling cited above and submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), as amended, is accepted subject to the comments reflected on the enclosed sheet. A copy of your proposed labeling stamped "ACCEPTED WITH COMMENTS" is enclosed.

WHAT THIS ACCEPTANCE MEANS:

Based on your certification, the Agency has accepted the labeling changes that are necessary to comply with the Worker Protection Standard (WPS) labeling requirements of 40 CFR part 156, subpart K, described in PR Notices 93-7 and 93-11. Any other labeling changes submitted in connection with this amendment application but not directly related to compliance with the WPS have not been reviewed or accepted by the Agency. If you wish to make such changes, you must submit a separate amendment application proposing them. If your product is currently suspended, the acceptance of this labeling amendment does not affect the suspension in any way.

By the next label printing make all the specified changes to your labeling. Send to EPA one (1) copy of the final printed labeling:



NON-AGRICULTURAL USE REQUIREMENTS

The requirements in this box apply to uses of this product that are NOT within the scope of the Worker Protection Standard for agricultural pesticides (40 CFR Part 170). The WPS applies when this product is used to produce agricultural plants on farms, forests, nurseries, or greenhouses.

Do not remain in treated areas

Leave room closed for at least one hour after application.

Keep children and pets out of the treated area until sprays have dried.

Ventilate prior to re-entry.

APPLICATION INFORMATION

SECTROL insecticide may be applied as a GENERAL SURFACE SPRAY.

Direct this spray onto floors, walls, into hiding places, moist areas, harborage areas, under pallets, around containers of stored food, around the base of machinery, behind shelves and drawers, and on or around insect entry areas. Spray directly on insects where possible.

FOR USE WITH COMPRESSED AIR SPRAYERS

For surface applications, apply SECTROL insecticide as a coarse wet spray. Apply at a rate of 1 gallon diluted product per 1,000 sq. ft. of surface. See dilution instructions for proper dilution ratio. When properly applied, SECTROL insecticide does not leave an excessive residue. If sprayed to run-off, SECTROL insecticide may be easily removed by wiping with a damp cloth or by vacuuming. SECTROL insecticide will not damage surfaces that are unaffected by water.

FOOD AREAS:

Food in immediate area should be removed or covered during treatment. All food contact surfaces and cooking utensils in immediate area should be covered during treatment or thoroughly cleaned before using. Treat areas for receiving, storage, preparing, processing, packaging, edible waste storage, and serving.

NON-FOOD AREAS:

Treat garbage rooms, lavatories, offices, machine rooms, boiler rooms, garages, closets, and storage areas. Spray baseboard areas, around water pipes, surfaces behind and beneath sinks, tables, cabinets, pallets, and areas where insects hide or through which they may enter. Repeat treatment as necessary.

FLEAS - a) On Household Surfaces - works up to 30 days. Thoroughly vacuum all carpeting, upholstered furniture, along baseboards, under furniture and in closets. Seal vacuum bag and dispose. Mop hard floors. Replace pet bedding. Using a smooth back-and-forth motion, spray (at a rate of 1 gal. diluted spray per 1,000 sq. ft. of surface) all floors and other aforementioned areas thoroughly, especially pet resting areas and other areas that pet frequents. Repeat application after 30 days as needed. Refrain from vacuuming treated areas until flea cycle is broken (normally 10-14 days). If you vacuum, retreat vacuumed areas.

b) On Dogs and Cats - works up to 8 days. For best results, shampoo pet with product recommended by veterinarian. Towel dry. Hold sprayer a few inches from pet. Start by spraying pet's head (avoiding contact with the eyes) and work your way back to the hind quarters. Spray under the haircoat by backcombing against the direction of hair growth with your other hand. It is important to wet the entire haircoat and any exposed skin thoroughly to assure adequate coverage. Allow pet to dry or use blow dryer. Do not towel dry as this will remove many of the microcapsules. Reapply weekly.

FOR USE WITH ULV EQUIPMENT

Close room or warehouse. Shut off all ventilation systems. Use a clean ULV sprayer adjusted to deliver an aerosol spray (no droplets over 50 microns in diameter and 80% less than 30 microns). Direct spray toward ceiling and upper corners of the area as well as behind and under obstructions. If using in conjunction with perimeter spraying, apply 3 fluid ounces of a 1:9 dilution per 1,000 cubic feet of space. Repeat applications as necessary. Food should be covered or removed during treatment. All food contact surfaces should be covered during treatment or thoroughly cleaned before using. Do not apply while food processing is underway.
