**Directions For Use** — It is a violation of federal law to use this product in a manner inconsistent with its labeling.

1. **SHAKE WELL BEFORE USING** to obtain a uniform dispersion of microcapsules. Adjust sprayer to deliver coarse wet spray.
2. Thoroughly apply the spray to infested areas, such as pet beds and resting quarters, along baseboards, and localized areas of floor and floor coverings where fleas and ticks may be present. Old bedding should be removed and replaced with clean, fresh bedding after treatment. Do not treat pets with this product.
3. Spray with a smooth back-and-forth motion to deposit product uniformly. It is not necessary to soak the treated surface, but an even treatment is desirable.
4. As fleas pick up or are bombarded by microcapsules of insecticide, the capsules begin to release their active ingredient. Noticeable flea reductions will be observed within 24 hours.

## CAUTION Precautionary Statements


