The microcapsules provide a "timed release" mechanism for the active ingredient, chlorpyrifos, to provide up to 90-day control of adult fleas and flea larvae. DIRECTIONS FOR USE: It is a violation of federal law to use this product in a manner inconsistent with its labeling.

SHAKE WELL BEFORE USING and fraquently during use. Adjust sprayer to deliver a coarse spray.

<u>Flea Treatment:</u> Thoroughly vacuum all carpeting, upholstered furniture, along baseboards, under furniture and in closets. Seal vacuum bag and dispose. Mop hard floors. Replace pet bedding. Using a smooth back-and-forth motion, spray all floors and other aforementioned areas thoroughly, especially pet resting areas and other areas your pet frequences. Provide a good, even treatment, but do not soak the areas you treat. You should begin to see a noticeable flea reduction within 24 hours. If fleas reappear about 1 - 2 weeks after treatment, it is because they've hatched from their pupal (cocoon) stage. (Flea control products are generally ineffective against pupae.) If you notice this problem, you should either repeat treatment or allow the product's time-release microcapsules another week to kill the newly-emerged fleas.
