Dear Doctor Ruth:

The labeling submitted in connection with registration for this product under the Federal Insecticide, Fungicide and Rodenticide Act is acceptable subject to the comments listed below. A stamped copy of the label is enclosed for your records.

1. Change the Precautionary Statements to read:

"Causes moderate eye irritation. Harmful if absorbed through the skin or inhaled. Avoid contact with skin, eyes or clothing. Wash thoroughly with soap and water after handling. Remove contaminated clothing and wash before reuse. Prolonged or frequently repeated skin contact may cause allergic reactions in some individuals."

2. Add the statement "Get medical attention" to the Statement of Practical Treatment for skin contact.

3. Add an additional Statement of Practical Treatment to read as follows:

If inhaled: Remove victim to fresh air. If not breathing, give artificial respiration. Get medical attention.

These changes are required based on the results of the Acute Inhalation and Dermal Sensitization studies submitted with your letter dated April 11, 1991. A copy of the review is enclosed for your information.
