- 4. The dermal irritation study for this product must be repeated, please refer to the enclosed copy of the toxicology review for our comments on the deficiences of the first study. You must submit the repeated study within 9 months of the date of this notice.

PESTICIDE STORAGE: Store product in original container out of the reach of children. Do not store above 120°F. Do not store below 32°F and avoid freezing to prevent container damage. If exposed to temperatures below 32°F, warm to room temperature and shake well before spraying.

PESTICIDE DISPOSAL: Securely wrap unused pesticide in original container in several layers of newspaper and discard in trash.

EMPTY CONTAINER DISPOSAL: Do not reuse bottle. Rinse thoroughly before discarding in trash.

Duratrol Plus Household Flea Spray is a unique combination of Esbiothrin and microencapsulated chlorpyrifos in a single formulation for fast knock-down and residual control of fleas and ticks. The microencapsulated chlorpyrifos provides up to 90-day control of adult fleas and flea larvae. Also kills many other household insects (See Directions For Use). For a total flea control program, ask your veterinarian about other DuratrolTM and SectrolTM microencapsulated flea and tick control products.

Directions for Use: It is a violation of federal law to use this product in a manner inconsistent with its labeling.

Before use, shake thoroughly and adjust sprayer to deliver a coarse spray.

Flea Treatment: Thoroughly vacuum all carpeting, upholstered furniture, along baseboards, under furniture and in closets. Seal vacuum bag and dispose. Wash or replace pet bedding. Using a smooth back-and-forth motion, spray all floors and other aformentioned areas thoroughly, especially pet resting areas and other areas your pet frequents. (See Precautionary Statements) Provide a good, even treatment, but do not soak the areas you treat. Mop hardwood floors. Duratrol Plus Household Flea Spray will not damage surfaces that are unaffected by water, however, delicate fabrics should be tested in an inconspicuous area before using this product. Do not treat human or animal bedding. You should begin to notice a reduction in adult fleas within hours. If adult fleas reappear about 1-4 weeks after treatment, it may be because they've hatched from their pupal (cocoon) stage. Flea control products are generally ineffective against pupae. If you notice this problem you should allow the product's microcapsules another few days to kill the newly emerged fleas. If fleas persist, contact your veterinarian before retreatment.
