Duratrol Plus Flea Spray for Dogs is a unique combination of esbiothrin and microencapsulated chlorpyrifos in a single formulation for fast knock-down and residual control of fleas and ticks. The microencapsulated chlorpyrifos provides up to 28-day control of adult fleas. For a total flea control program, ask your veterinarian about other Duratrol™ and Sectrol™ flea and tick control products.

FOR RESIDUAL 28-DAY CONTROL OF FLEAS AND 7-DAY CONTROL OF BROWN DOG TICKS:

Directions for Use: It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

1. Before use, shake thoroughly and adjust sprayer to deliver a coarse spray.
2. Hold spray nozzle 4-6 inches from the pet. Apply DURATROL PLUS FLEA SPRAY FOR DOGS to the hair and skin by brushing back the haircoat while spraying. Moisten the skin but do not soak to dripping.
3. Avoiding the pet's eyes and nose, spray the pet evenly over all areas of the body.
4. Allow the pet to air dry. Do not towel dry as this can remove many DURATROL PLUS FLEA SPRAY microcapsules. A blow dryer may also be used.
5. Wash hands thoroughly with soap and water after application.
6. Repeat as necessary, but no more frequently than every 3 weeks.

PRECAUTIONARY STATEMENTS:

CAUTION

HAZARDS TO HUMANS:

Active ingredient is a cholinesterase inhibitor. Treat symptomatically. Atropine by injection only, is the preferable antidote. Oximes, such as 2-PAM/Protopam, may be therapeutic if used early, however use only in conjunction with atropine.

ENVIRONMENTAL HAZARDS:

This product is toxic to fish, birds, and other wildlife. Do not contaminate water by cleaning of equipment or disposal of equipment washwaters.

PESTICIDE STORAGE:

Store product in original container out of the reach of children. Do not store above 100 °F. Do not store below 32° F. and avoid freezing to prevent container damage. If exposed to temperatures below 32° F., warm to room temperature and shake well before spraying.

PESTICIDE DISPOSAL:

Securely wrap unused pesticide in original container in several layers of newspaper and discard in trash.

EMPTY CONTAINER DISPOSAL:

Do not reuse container. Rinse thoroughly before discarding in trash.
