Your Application Dated October 19, 1993

The amendment referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), sec. 3(c)(7)(A), is acceptable provided that you:

1. Submit and/or cite all data required for registration/reregistration of your product under FIFRA sec. 3(c)(5) when the Agency requires all registrants of similar products to submit such data.
2. Make the following labeling change before you release the product for shipment bearing the amended labeling:
  - Add the restriction: "Do Not Use On Cats" to the Directions for Use. We note that this restriction should still appear in the Precautionary Statements section, as shown on the submitted labeling.
3. Submit five (5) copies of your final printed labeling before you release the product for shipment.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA sec. 6(e). Your release for shipment of the product bearing the amended labeling constitutes acceptance of these conditions.

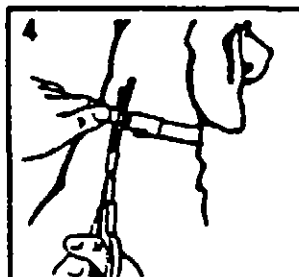
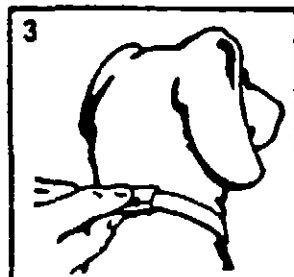
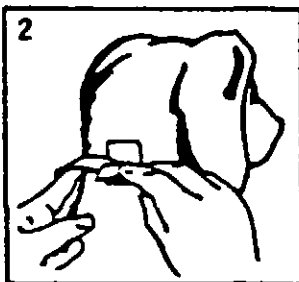
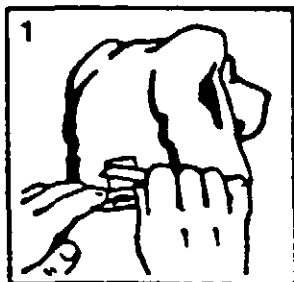
This collar works best as a supplement to a total flea control program. It provides long lasting protection to help prevent infestation or reinfestation of fleas. It kills ticks that may carry and transmit disease; it also kills ticks that may carry and transmit Lyme Disease.

This collar also contains Bitrex<sup>®</sup>, a bittering agent to discourage chewing.

This collar starts killing fleas and ticks as soon as it is placed around the dog's neck and will provide effective head to tail control of fleas within 1 day. New fleas and ticks which may temporarily appear on the dog will also be killed while the collar is worn. This collar has been shown to provide effective flea kill up to 8 months and tick kill up to 5 months. During the first few days of use, inspect the dog's neck daily for any signs of irritation. Replace collar as frequently as directed by your veterinarian.

**Directions for Use**—It is a violation of federal law to use this product in a manner inconsistent with its labeling.

1. Put the collar around the dog's neck so the ends overlap in the open clasp (see fig. 1).
2. Adjust the collar so it fits with room for two or three fingers between the collar and the dog's neck (see fig. 2).
3. Snap the clasp closed (see fig. 3). This collar may be removed by flexing open the thumb latch on the clasp. To reattach the collar, repeat steps 1-3.
4. Cut off excess length (see fig. 4).
5. Wash hands thoroughly after handling this collar.



Note: Occasional fraying of the collar edge may be observed during wear; this does not adversely affect collar performance.

### Precautionary Statements

**Hazards To Humans:** Avoid contact with eyes. Do not allow children to play with this collar. Some people may be sensitive to insecticides.

**Hazards To Humans and Domestic Animals:** Do not apply to cats, to puppies less than 12 weeks of age or to bitches nursing puppies. Do not apply to sick or debilitated animals. Do not use this product simultaneously with other cholinesterase inhibiting drugs, pesticides, or chemicals. Some animals may be sensitive to insecticides. This product is toxic to fish, birds and other wildlife.

### Statement of Practical Treatment

In case of contact with eyes, immediately flush with plenty of water. Get medical attention if persistent irritation results.

Active ingredient is a cholinesterase inhibitor. Treat symptomatically. Atropine, by injection only, is preferable antidote. Oximes, such as 2-PAM/Protopam, may be therapeutic if used early; however, use only in conjunction with atropine.

**Pesticide Storage:** Store product in original container out of the reach of children.

**Pesticide and Empty Container Disposal:** Securely wrap excess collar and original container in several layers of newspaper and discard in trash.
