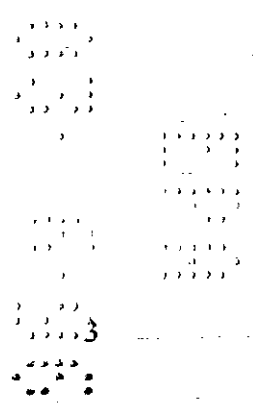

**DILUTION INSTRUCTIONS:**

Shake CONCENTRATED SECTROL well before diluting. Mix well after diluting.

For General Use Including Preventive Maintenance and Use on Dogs and Cats:

Dilute 1 part CONCENTRATED SECTROL with 19 parts water (6.4 fl. oz./gallon)

For Severe Infestations on Premises:

Dilute 1 part CONCENTRATED SECTROL with 9 parts water (12.8 fl.oz./gallon)

**APPLICATION INFORMATION:**

Diluted CONCENTRATED SECTROL may be applied as a GENERAL SURFACE SPRAY

Direct this spray onto floors, walls, into hiding places, moist areas, harborage areas, under pallets, around containers of stored food, around the base of machinery, behind shelves and drawers, and on or around insect entry areas. Spray directly on insects where possible.

**For Use with Compressed Air Sprayers**

Before use, clean sprayer with warm, soapy water to remove residues of previously used products. Rinse and flush sprayer with clean water before using insecticide.

For surface applications, apply insecticide as a coarse wet spray. Apply at a rate of 1 gallon diluted product per 1,000 sq. ft. of surface. See dilution instructions for proper dilution ratio. When properly applied, this insecticide does not leave an excessive residue. If sprayed to run-off, this insecticide may be easily removed by wiping with a damp cloth. This insecticide will not damage surfaces that are unaffected by water

**Shake thoroughly and adjust Compressed Air Sprayer to deliver coarse wet spray**

**Food Areas:** Food in immediate area should be removed or covered during treatment. All food contact surfaces and cooking utensils in the immediate area should be covered during treatment or thoroughly cleaned with an effective cleaning compound followed by a rinse with potable water prior to reusing. Treat areas for receiving, storage, preparing, processing, packaging, edible waste storage and serving.

**Non-Food Areas:** Treat garbage rooms, lavatories, offices, machine rooms, boiler rooms, garages, closets, and storage areas. Spray baseboard areas, around water pipes, surfaces behind sinks, tables, cabinets, pallets, and other areas where insects hide or through which they may enter. Repeat treatment as necessary.

**In Hospitals:** Remove patients prior to treatment. Ventilate rooms for 2 hours before returning patients.

**FLEAS ON HOUSEHOLD SURFACES - works up to 30 days.**

1. Thoroughly vacuum all carpeting, upholstered furniture, along baseboards, under furniture and in closets. Seal vacuum bag and dispose of in outdoor trash container. Mop hard floors. Replace pet bedding.
2. Using a smooth back-and-forth-motion, spray (at a rate of 1 gallon diluted spray per 1,000 sq. ft. of surface) all floors and other aforementioned areas thoroughly, especially pet resting areas and other areas that pet frequents. Repeat application after 30 days or as needed. Refrain from vacuuming treated areas until flea cycle is broken (normally 10-14 days). If you vacuum, retreat vacuumed areas.

**FLEAS AND TICKS ON DOGS AND CATS - works up to 8 days.**

1. For best results, shampoo pet with an insecticidal shampoo recommended by a veterinarian or an appropriate pesticidal shampoo. Prior to application, rinse shampoo thoroughly from haircoat and towel to remove excess water.
2. Hold spray nozzle 4-6 inches from the pet. Apply to the hair and skin by brushing back the haircoat while spraying. Moisten the skin but do not soak to dripping.
3. Avoiding the pet's eyes and nose, spray the pet evenly, over all areas of the body.
4. Allow the pet to air dry. A blow dryer may also be used.
5. Wash hands thoroughly with soap and water after application.
6. Applied as directed, CONCENTRATED SECTROL will provide flea kill for up to eight days. For best flea and tick control, reapply weekly.
