- c. The statements "Do not spray directly on animals or humans.", "Do not spray directly onto animals, feedstuffs or water. Do not spray while animals are present. Avoid contamination of animals feedstuffs and water by spray drift.", and "Do not spray in milk storage rooms. Do not contaminate milking or milk handling equipment.". ### PREPARATION:

Use a clean compressed-air sprayer or cold-mist fogger. Prepare the amount of spray desired by diluting 2/3 fl. oz. (2 tsp.) of PERMETHRIN 20 MEC LIVESTOCK PREMISE SPRAY CONCENTRATE into 1 (one) gallon of water. SHAKE WELL.

#### APPLICATION INFORMATION:

Adjust the fogger or sprayer nozzle to deliver a coarse, wet spray. Apply to the point of runoff (approximately (1) one gallon of spray per 750-1000 square feet of surface).
