DIRECTIONS FOR USE: It is a violation of Federal law to use this product in a manner inconsistent with its labeling. Do not apply this product in a way that will contact workers or other persons either directly or through drift. Only protected handlers may be in the area during application.

APPLICATION INSTRUCTIONS:

The use of pheromone monitoring traps and routine inspection of foliage and fruit for the presence of larvae or larval damage is strongly recommended to determine the need and timing for application of this product. This product is an effective tool to help manage Sparganothis Fruitworm populations in cranberry crops. 3M Sprayable Pheromone can reduce or in some cases prevent mating by interfering with the chemical communication system between male and female moths. Reduced mating results in a decrease in the number of eggs laid and lower larval populations thereby reducing the need for conventional insecticides. Supplemental insecticides may be required if initial populations in the treated area are too high, or if a major source of mated females is present in areas adjacent to the treated area. Treated areas should be thoroughly monitored for the presence of other pests and treated if necessary. SHAKE WELL BEFORE USE. The recommended rate of application per treatment is 1.7 - 4 US fl. oz/acre or 50 - 125 mls. product/acre (10 - 25 g. ail/acre), applied in sufficient quantities of water to ensure uniform coverage. This product can be applied with conventional ground and aerial application equipment and most types of irrigation systems (see section on chemigation). Two (2) applications of 3M Sprayable Pheromone per adult moth flight are recommended. This product should be applied just prior to the start of the Spring and Summer adult moth flight periods. Consult your local pest advisor for information on timing . Repeat applications should be made at 2 - 3 week intervals. High temperatures may require more frequent applications. Do not exceed 150 g. at/acre/year (750 mis. product/acre/year.

Apply this product only through lateral move, end tow, side (wheel) roll, traveler, big gun, solid set or hand move sprinkler systems. Do not apply this product through any other type of irrigation system. Crop injury or lack of effectiveness can result from non-uniform distribution of treated water. Do not connect an irrigation system (including greenhouse systems) used for pesticide application, to a public water system unless the pesticide label prescribed safety devices for public water systems are in place.

Chemigation Systems Connected to Public Water Systems:

Public water system means a system for the provision of piped water, to the public, for human consumption if such a system has at least 15 service connections or regularly serves an average of at least 25 individuals daily, at least 60 days of the year.

Chemigation systems connected to public water systems must contain a functional, reducedpressure zone (RPZ) backflow preventer or the functional equivalent, in the water supply line upstream from the point of pesticide introduction. An additional option to the RPZ, the water from the public water system can be discharged into a reservoir tank prior to pesticide introduction. There should be a complete physical break (air gap) between the outlet end of the fill pipe and the top or overflow rim of the reservoir tank, of at least twice the inside diameter of the fill pipe.

The pesticide injection pipeline must contain a functional, automatic, quick-closing check valve to prevent the flow of fluid back toward the injection pump.

The pesticide injection pipeline must contain a functional, normally closed, solenoidoperated valve located on the intake side of the injection pump and connected to the system interlock to prevent fluid from being withdrawn from the supply tank when the irrigation system is either automatically or manually shut down.

The system must contain functional interlocking controls to automatically shut off the positions in pump when the water pump mutur stops, or in cases where there is no water pump, when the water pressure decreases to the point where posticide distribution is adversely affected. Systems must use a metering pump (e.g. Disphragm pump) effectively designed and constructed of materials that are compatible with pesticides and capable of being fitted with a system interlock.

Do not apply when wind speed favors drift beyond the area intended for treatment. Sprinkler Chemigation:

The system must contain a functional check valve or appropriate gooseneck pipe loop, vacuum relief valve and low pressure drain appropriately located on the irrigation

pipeline to prevent water source contamination from backflow.

The pesticide injection pipeline must contain a functional automatic, quick-close check valve to prevent the flow of fluid back toward the injection pump.

The pesticide injection pipeline must also contain a functional, normally closed, solenoid-operated valve located on the intake side of the injection pump and connected to the system interlock to prevent fluid from being withdrawn from the supply tank when the irrigation system is either automatically or manually shut down. The system must contain functional interlocking controls to automatically shut off the pesticide injection pump when the water pump motor stops.

The irrigation line or water pump must include a functional pressure switch which will stop the water pump motor when the water pressure decreases to the point where pesticide distribution is adversely affected. Systems must use a metering pump, such as a positive displacement injection pump (e.g. diaphragm pump) effectively designed and constructed of materials that are compatible with pesticides and capable of being fitted with a system interlock.

Do not apply when wind speed favors drift beyond the area intended for treatment. Adequate agitation must be provided before and during the injection period. Use only in sprinklers that apply uniformly and have appropriate check valves. When application of pesticide is complete, thoroughly flush the injection system and sprinkler lines.

Mixing Recommendations for Chemigation:

Follow general mixing instructions and keep the ratio at three (3) parts water to one (1) part 3M Sprayable Pheromone Concentrate. Also, provide mild uniform agitation throughout the solution but do not agitate excessively.

Spray Volume:

For chemigation, volume of make-up solution about correspond to a 6 to 8 minute injection time, resulting in a per acre volume of approximately 400 to 600 gallons of water, excluding rinse-out volume. This pheromone product should be applied continuously for the duration of the water application. When application of pesticide is complete, thoroughly flush the injection system and sprinkler lines with a minimum volume of water for complete rinse-out.
