3M LR-3500 Copper Granules contain copper oxide, an effective algaecide for inhibiting the growth of blue-green algae that can stain roofing shingles. The granules are treated roofing granules 1-2 mm in diameter made from rock coated with copper oxide and sealed in a ceramic shell. The ceramic shell allows a timed release of copper to provide long-lasting algae control that extends the useful life of shingles. The granules are colored to match the roofing shingles.

3M LR-3500 Copper Granules should be mixed with standard roofing granules at the rate of 5-10% by weight and processed normally during manufacture of the shingles.
