

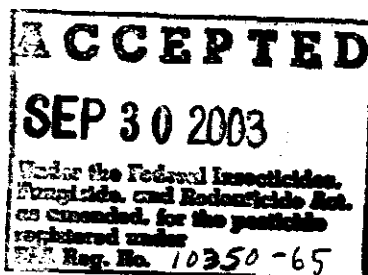
### Directions for Use
