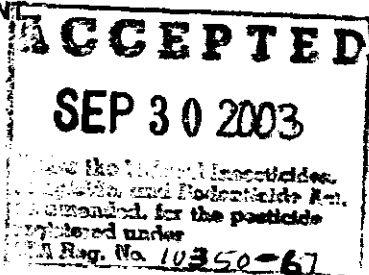
### Directions for Use
