

STORAGE AND HANDLING

AQUCAR *545 solutions are corresive to many commonly used materials of construction such as steel, gatvanized iron, aluminum, tin, and zinc. These solutions can be stored and handled in baked phenotic-lined steet, polyethylene, stainless steel, or reinforced epoxy-plastic equipment. This product freezes at about -17°C (1°F). Therefore, unless the storage tank is inside or underground, heating and insulation may be required. If heating is needed, exposure to high temperatures should be avoided. For short storage times (up to about 1 month). temperatures of up to 100°F can be tolerated but the preferred maximum storage temperature is about 80°F.

A stainless steel centrifugal pump is suggested for transfer service, Asbestos is suitable for gaskets and packing.

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal. Open dumping is prohibited. Pesticide wastes are toxic. Improper disposal of excess posticide, spray mixture or rinsate is a violation of Federal Law. AIR WASHERS AND RECIRCULATING COOLING WATER SYSTEMS

This product may be used only in industrial air weehers and air weeher systems which have mist-eliminating components. ACUCAR["646 Water Treatment Microblocide should be added at the application rases described below, to a water treatment system at a convenient point of uniform mixing such as the besin area. Addition may be made intermittently (SLUG DOSE) or continuously. Bettly followed systems can be shock treated with ACUCAR["645. Under these conditions, blowdown should be discontinued for up to 24 hours.

INTERMITTENT (SLUG DOSE) METHOD

Initial Dass: When the system is noticeably fouled, apply 12.7-25.5 fluid ounces of AQUCAR[*645 per 1000 gallons of water in the system. Repeat until control is achieved.

Subsequent Dass: When microbial control is evident, add 8.1-12.7 fluid ounces of AQUCAR[*645 per 1000 gallons of water to the system weekly, or as needed to maintain control.

Badly fouled systems must be cleaned before treatment is begun.

CONTINUOUS FEED METHOD

Initial Dose: When the system is noticeably fouled, apply 12.7-25.5 fluid ounces of AQUCAF[~545 per 1000 ballons of water in the system.

Subsequent Deer: Maintain this treatment level by starting a continuous feed of 2.8-12.7 fluid ounces of AQUCARTS45 per 1000 gallons of water in the Pystem per day. Budly fouled systems must be Cleaned before treatment is begun.

BREWERY PASTEURIZER COOLING WATER SYSTEMS

AQUCAR!*545 should be used at the same application rates, and in the same manner as described above. It should be added to the closed recirculating system at a convenient point of uniform mixing such as a beats area, sump area, or other reservoir or collecting area from which the treated water will be circulated uniformly throughout the pastaurizer cooling water system.
