

For short storage times (up to about 1 month), temperatures of up to 100°F (37.8°C) can be tolarated but the preferred maximum storage temperature is about 80°F (26.7°C). A stainless steel centrifugal pump is suggested for transfer service. Spiral wound stainless steel with TEFLON® is suitable for gaskets and packing.
