DIRECTIONS FOR USE

To control FIRE ANTS use 50 pounds minimum of this product broadcast per acre. For individual mound treatment, use 4 ounces per square foot. To control ANTS, JAPANESE BEETLE LARVAE, WHITE GRUBS, EARWIGS, and WIREWORMS use 80 pounds of this product broadcast per acre to turf or soil and wash into soil lightly.

Do not allow children or pets on treated lawn area until the insecticide has been washed off the grass into the soil and the area completely dry.

WARNING

Do not inhale dust. Do not get on skin. Harmful if swallowed. Wash after handling. Avoid contamination of feed and foodstuffs.
