STATEMENT OF PRACTICAL TREATMENT

IF SWALLOWED: Call a physician or Poison Control Center immediately. Product contains a Petroleum Distillate. Do not induce vomiting unless under the supervision of a physician. PRECAUTIONARY STATEMENTS

HAZARDS TO HUMANS AND DOMESTIC ANIMALS

DIRECTIONS FOR USE (Cont.)

INDOOR PEST CONTROL

For COCKROACHES, ANTS, SILVERFISH, SPIDERS, CRICKETS AND EARWIGS: Spray areas where these pests are found or may hide, including dark corners of rooms and closets, crack and crevices, along baseboards and door sills and frames, behind and beneath sinks, stoves, refrigerators, and cabinets and around garbage cans, plumbing and other utility installations. Pests driven out of hiding places should be sprayed directly. Spray ant trails, nests and points of entry.

OUTDOOR PEST CONTROL

For BROWN DOG TICKS: Apply thoroughly as a spot treatment to infested areas such as pet beds and resting quarters, nearby cracks and crevices, along and behind baseboards, windows, and door frames and localized areas of floor and floor coverings where these pest may be present. Fresh bedding should be placed in animal quarters following treatment. Do not spray pests with this product.

For FLIES AND MOSQUITOES: Use only on outdoor surface. Spray outside surfaces of windows and door frames and other areas where these pests may enter the home. Also spray dark corners and localized resting areas, such as under eaves, porches, partitions, and in garages where these insect may congregate. Flies and Mosquitoes coming to rest on treated surfaces will be killed. Repeat treatment when effectiveness diminishes.
