Subject: Amended Labeling  
Ford's Aquakill Roach and Ant Spray  
EPA Registration No. 10370-29  
Your Application Dated March 7, 1994

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable, subject to the comments listed below.

1. In the Ingredients Statement, correct the spelling of the chemical name for chlorpyrifos (ie. -trichloro-).
2. In the Environmental Hazards statement, replace the phrase: "disposal of wastes" with: "disposal of equipment washwaters".
3. Add the heading "Precautionary Statements" prior to the phrase "Hazards to Humans". Additionally, add "and Domestic Animals" to this phrase.
4. Change the heading "Use Directions" to "Directions for Use".
5. The instruction which begins "Do not apply sprays of this product in conduits, motor housings..." should be placed in the Physical and Chemical Hazards section, and should not appear in the Directions for Use.
6. The statements appearing in the Directions for Use regarding contact of food, feedstuffs and water supplies; thorough washing of dishes etc.; and the instruction to not allow children or pets to contact treated surfaces, should all be placed in the Precautionary Statements section.

7. In the Directions for Use outdoors to control flies and mosquitoes, correct the typographical error in the second to last sentence - "placed" should be "places".

A stamped copy of the label is enclosed for your records. Two copies of final printed labeling, which incorporates the revisions noted above, should be submitted for our files.

### Hazards To Humans

**CAUTION**

Avoid contact with eyes, skin and clothing. Avoid breathing vapors or spray mist. Keep away from food, feedstuffs and domestic water supplies. Wash thoroughly after handling.

### Environmental Hazards

This product is highly toxic to bees exposed to direct treatment or residue on plants. Protective information may be obtained from your Cooperative Agricultural Extension Service. Ford's Aqua Kill is toxic to fish, birds and other wildlife. Keep out of lakes, streams, ponds, tidal marshes and estuaries. Shrimp and crabs may be killed at application rates recommended on this label. Do not apply where these are important resources. Do not apply when weather conditions favor drift from areas treated. Do not contaminate water by cleaning of equipment or disposal of wastes.

### Physical Or Chemical Hazards

DO NOT USE OR STORE NEAR HEAT OR OPEN FLAME. DO NOT STORE BELOW 32°F.

### USE DIRECTIONS

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

### DISPOSAL

Do not reuse empty container. wrap container and put in trash collection.

### PESTS INDOORS

General information: Use Aqua Kill insecticide to control the pests indicated in the areas listed below by application of the product as an undiluted spray (0.5% chlorpyrifos). Repeat the treatment as needed.

Do not apply sprays of this product in conduits, motor housings, junction and switch boxes or other electric equipment because of possible shock hazard. Do not use in poultry houses or other animal buildings. Do not allow spray to contact food, feedstuffs, and water supplies. Thoroughly wash dishes and food-handling utensils with soap and water if they become contaminated by application of this product. Do not allow children or pets to contact treated surfaces until spray has dried. Remove pets and cover fish bowls (tanks) before spraying. Application within residential buildings including homes and apartment buildings and within non-food areas of industrial, institutional and commercial buildings including hospitals, stores, manufacturing plants and warehouses. For spot treatment only: Apply as a coarse spray or with a paint brush to localized areas where cockroaches (including strains resistant to certain other insecticides), ants, clover mites, crickets, firebrats, silverfish, and spiders are found or normally occur, including dark corners of rooms and closets, cracks and crevices in walls, along and

behind baseboards, beneath and behind sinks, stoves, refrigerators and cabinets, around plumbing and other utility installations. For ants: apply to ant trails, also around doors and windows and wherever else these pests may find entrance. NOTE: A period of four to seven days is normally required for maximum effect on cockroaches.

For control of *Carpet Beetles*, thoroughly apply as a spray for spot treatment along baseboards and edges of carpeting, under carpeting rugs and furniture, in closets and on shelving, and wherever else these insects are seen or suspected.

For control of *Fleas and Brown Dog Ticks*, thoroughly apply as a spray for spot treatment to infested areas such as pet beds and resting quarters, nearby cracks and crevices, along and behind baseboards window and door frames and localized areas of floor and floor coverings where these pests may be present. Old bedding of pets should be removed and replaced with clean, fresh bedding after treatment of pet area. DO NOT TREAT PETS WITH THIS PRODUCT. To control the source of flea infestation, pets inhabiting the treated premises should be treated with a product registered for application to animals.

#### PESTS OUT-OF-DOORS

**FLIES, MOSQUITOES:** For outdoor use only as an aid in reducing annoyance from these insects. Spray outside surfaces of screens, doors, windows frames or wherever these insects may enter the room. Also treat surfaces around light fixtures on porches, in garages and other places where these insects alight or congregate. Repeat as necessary.

**ANTS, BROWN DOG TICKS, CRICKETS, FLEAS AND EARWIGS:** For treatment of localized infestations of these insects in outdoor areas where there are weeds or bushy non-crop areas, spray infested areas thoroughly. For ants, thoroughly wet hills and runways. Repeat applications as infestations warrant and as reinfestations occur.

**IMPORTED FIRE ANTS:** To treat *Fire Ant* mounds, use Ford's Aqua Kill Roach and Ant Spray as a drench treatment. Gently sprinkle 1 gallon of Ford's Aqua Kill over the surface of each mound using a sprinkler can. Thoroughly wet the mound and surrounding areas to a 4 ft. diameter (12 sq. ft.). For best results, apply in cool weather, 65-80°F or in early morning or late evening hours. Treat new mounds as they appear. Pressurized sprays may disturb the ants and cause migration, reducing product effectiveness.
