Hazards to Humans and Domestic Animals CAUTION: KEEP OUT OF REACH OF CHILDREN. MAY BE HARMFUL IF SWALLOWED. May be absorbed through skin. Do not take internally. STATEMENT OF PRACTICAL TREATMENT

IF SWALLOWED: Call a physician or poison control center immediately. Drink 1 or 2 glasses of water and induce vomiting by touching back of throat with linger. Repeat until vomit fluid is clear. Do not induce vomiting or give anything by mouth to an unconscious person. IF INHALED: Remove victim to fresh air. Apply respiration if indicated. IF ON SKIN: Remove contaminated clothing and wash affected area with soap and water. IF IN EYES: Flush eyes with plenty of water and call a physician immediately

This product is toxic to fish, birds, and other wildlife. Do not apply directly to water. Do not contaminate water by cleaning of equipment or disposal of wastes. Cockroaches (Waterbugs): Dust thoroughly all areas where roaches crawl and hide such as around water pipes, in cracks and crevices under and behind cabinets refrigerators, and sinks Ants and Silvertish: Dust thoroughly areas around water pipes in cracks, under and behind cabinets, refrigerators, and silves, and around doors, windows, and bookcases Carpet Boetles: Dust along baseboards, under carpeting, rugs, furnitura, and wherever these insects are seen or suspected

Spiders and Scorpions: Dust around windows, doors, and along baseboards. Make spot applications to surfaces over which these pests crawl, particularly in crawl spaces under houses or buildings

DIRECTIONS FOR APPLICATION WITHIN FOOD AREAS AND NON-FOOD AREAS OF FOOD HANDLING ESTABLIS. IMENTS

For control of Cockroaches (Waterbugs). Ants. Spiders, Scorpions. Silverfish. Pantry Pesis - exposed stages (Sawtooth, Grain Beetle, Rice Weevit, Cigarette Beetle, Drugstore Beetle, Indial Meal Moth)

Food Handling Establishments -- Places other than private residences in which exposed food is held, processed, prepared or served.

Food Areas Application Limited to Creck and Crewice Treatment Only --- includes areas for receiving, storage, packing (canning, bottling, wrapping, boxing) preparing, dible waste storage and enclosed processing systems (mills, dairies, edible oils, syrups). Serving areas (when food is exposed and facility is in operation) would also be considered a food area.

Apply Diazinon 2D Dust in small amounts directly into cracks and crevices using a bulbous duster or other suitable equipment capable of applying insecticide directly into cracks and crevices, in points between different elements of construction, between equipment and floors, openings leading to voids and hollow spaces in walls, equipment legs and bases where insects hide. Care should be taken to avoid depositing the product onto exposed surfaces or introducing the material into the air. Avoid contamination of food or food process-

ing surfaces. APPLICATIONS OF THIS PRODUCT IN THE FOOD AREAS OF FOOD HANDLING ESTABLISHMENTS, OTHER THAN AS A CRACK AND CREVICE TREATMENT.

ARE NOT PERMITTED. Application in Non-Food Areas — Includes garbage rooms, lavatories, floor drains (to sewer entries and vestibules, offices, locker rooms, machine rooms, boiler

rooms, garages, mop closets and storage (after canning or bottling). Apply Diazinon 2D Dust thoroughly to all areas where insects hide or through which they may enter the building, including around water pipes, wall voids, under and behind lockers, and cabinets.

Note: Diazinon 2D Dust is useful where sprays might be difficult to apply, as in wall voids. Avold the use of dust where there is wind, sweeping, traffic or other activity that would cause the dust to be transferred or become airborne. Any dust left in the open, after application, must be brushed into cracks or otherwise removed.
