Dear Mr. Boyd:

The amendmenus referred to above, submitted in connection with a registration under the Pederal Insecticide, Fungicide, and Rodenticide Act, are acceptable provided the following revisions are made prior to release for shipment under the amended labeling:

- 1) All the handwritten revisions and deletions indicated on the submitted latel must be incorporated in the finished label.
- 2) In the newly added directions for "Nuisance Pests Outside the Home", the mixing instructions "Mix 3 fl. cz. in 3 gallons of water" should appear appear as a separate paragraph so that it will pertain to both paragraphs that follow. Also, in this same section, delete "and ceilings" from "porch and patio walls and ceilings. Such use, especially if applied to runoff, could result in pesticide "raining" down on the applicator. Since no head protection (such as a wide brimmed hat) is called for in the current precautionary text, spray could conceivably drip down behind safety glasses and into eyes.

A stamped copy of the label is enclosed for your records. Please submit five (5) copies of the revised amended label prior to release for shipment under the amended label.



Please refer to the Diazinon Registration Standard, as amended, for release for shipment and channels of trade dates for diazinon products bearing appropriately amended labels.

# CHEMIGATION

# APPLICATION THROUGH AN IRRIGATION SYSTEM (CHEMIGATION) - CRANBERRIES ONLY

diazinon AG500 may be applied alone or in combination with other pesticides registered for application through sprinkler irrigation systems to cranberries. To insure compatibility, pour the products into a small container of water in the correct proportions. After thorough mixing, let stand for five minutes. If the combination remains mixed, or can be remixed readily, the mixture is compatible.

Do not apply this product through any type of irrigation system to other crops. For chemigation, apply this product to cranberries only through sprinkler irrigation systems. Do not apply this product to cranberries through any other type of irrigation system.

Crop injury, lack of effectiveness, or illegal pesticide residues in the crop can result from non-uniform distribution of treated water. If you have questions about calibration, you should contact State Extension Service specialists, equipment manufacturers or other experts.

Do not connect the irrigation system used for pesticide application to a public water system unless the pesticide label-prescribed safety devices for public water systems are in place. A person knowledgeable of the chemigation system and responsible for its operation, or under the supervision of the responsible person, shall shut the system down and make necessary adjustments if the need arises.

## Chemigation System Connected to Public Water Systems

- 1. Public water system means a system for the provision to the public of piped water for human consumption if such system has at least 15 service connections or regularly serves an average of at least 25 individuals daily at least 60 days out of the year.
- 2. Chemigation systems connected to public water systems must contain a functional, reduced-pressure zone, backflow preventer (RPZ) or the functional equivalent in the water supply line upstream from the point of pesticide introduction. As an option to the RPZ, the water from the public water system should be discharged into a reservoir tank prior to pesticide introduction. There shall be a complete physical break (air gap) between the outlet end of the full pipe and the top or overflow rim of the reservoir tank of at least twice the inside diameter of the fill pipe.

#### Sprinkler Chemigation

- 1. The system must contain a functional check valve, a vacuum relief valve, and low pressure drain appropriately located on the irrigation pipeline to prevent water source contamination from backflow.
- 2. The pesticide injection pipeline must contain a functional, automatic, quick-closing check valve to prevent the flow of fluid back toward the injection pump.
- 3. The pesticide injection pipeline must also contain a functional, normally closed, solenoid-operated valve located on the intake side of the injection pump and connected to the system interlock to prevent fluid from being withdrawn from the supply tank when the irrigation system is either automatically or manually shut down.
- 4. The system must contain functional interlocking controls to automatically shut off the pesticide injection pump when the water pump motor stops.
- 5. The irrigation line or water pump must include a functional pressure switch which will stop the water pump motor when the water pressure decreases to the point where pesticide distribution is adversely affected.

- 6. Systems must use a metering pump, such as a positive displacement injection pump (e.g., diaphragm pump) effectively designed and constructed of materials that are compatible with pesticides and capable of being fitted with a system interlock.
- 7. Do not apply when wind speed favors drift beyond the area intended for treatment.

#### Operating Instructions

- 1. Determine the acreage to be treated by the sprinkler system.
- 2. Measure the appropriate amount of diazinon AG500 needed to treat the acreage to be treated. Refer to the specific directions for use for cranberries for the application rate and the amount of water per acre.
- 3. Add the pre-measured diazinon AG500 to the chemigation system supply tank and dilute with water if needed. Proper agitation is needed if diazinon AG500 is tank mixed with other pesticides registered for sprinkler chemigation application to cranberries.
- 4. Start the irrigation system and bring the system up to full pressure, making certain that all sprinkler heads are functioning properly.
- 5. Engage the chemigation injection or venturi system to add the diazinon to the irrigation lines.
- 6. Continue to run irrigation system for a few minutes after supply tank is empty to allow material in the irrigation lines to reach the sprinkler heads furthest from the chemigation injection point.

When a mixture of two or more organophosphate pesticides are applied in combination, the interval should be prolonged by adding to the largest applicable interval an additional 50% of that interval.

The rate of diazinon AG500 for concentrate ground and aerial sprays is based on a dilute full cover with conventional ground equipment applied at 300-600 gallons of water per acre. If directions call for 1 pt. of diazinon AG500 in 100 gallons of water this amounts to 3-6 pts. per acre when applied at dilute ground spray volumes.




