

CONTACT SPRAY - KILLS AND REDUCES INFESTATIONS: Cockroaches, Crickets. Silverfish, Clover Mites, Centipedes, Millipedes, Firebrats, Earwigs, Sowbugs, Ants, Spiders, Fleas: Use as a spot treatment. When possible, spray directly on pests to reduce infestations. Apply as a coarse spray or with a paint brush into hiding places such as cracks, crevices, moist areas, openings around pipes and sinks, appliances, under refrigerators and other baseboards and storage areas. Apply spray until area is wet, but not to the point of run-off. Repeat as necessary.

ANTS: To kill *Ants*, spray trails, nests and points of entry within buildings and homes. Spray directly on ants where possible. Repeat as necessary.

FLEAS, BROWN DOG AND LONE STAR TICKS: Thoroughly apply as a spot treatment to infested areas such as pet's beds and resting quarters; nearby cracks and crevices; along and behind baseboards, window and door frames and localized areas of floor and floor covering where these pests may be present. Old bedding of pets should be removed and replaced with clean fresh bedding after treatment of pet areas. DO NOT TREAT PETS WITH THIS PRODUCT. HOUSEFLIES, MOSQUITOES OUTDOORS: For outdoor use only as an aid in reducing annoyance from these insects. Spray outside surfaces of screens doors window frames or wherever these insects may enter the room. Also treat surface around light fixtures on porches in garages and other places where these insects alight or congregate. Repeat as necessary.

ANTS, BROWN DOG TICKS, CRICKETS, FLEAS, AND EARWIGS OUTDOORS: For treatment of localized infestations of these insects in outdoor areas where there are weeds or bushy non-crop areas spray infested areas thoroughly. For Ants thoroughly wet hills and runways. Repeat application as infestations warrent and as reinfestations occur.
