STATEMENT OF PRACTICAL TREATMENT

IF ON SKIN: Wash with plenty of soap and water. Get medical attention if irritation persists. **IF IN EYES:** Flush eyes with plenty of water for 5 minutes. Get medical attention if irritation persists. **IF SWALLOWED:** Drink 1 or 2 glasses of water and induce vomiting by touching back of throat with finger. Do not give anything by mouth to an unconscious person. Get medical attention. **NOTE TO PHYSICIAN:** Chloryprifos is a cholinesterase inhibitor. Treat symptomatically. Atropine only by injection is an antidote.

ENVIRONMENTAL HAZARDS

This product is highly toxic to bees exposed to direct treatment or residues on plants. Protective information may be obtained from your Cooperative Agricultural Extension Service. D-Plus Dust is toxic to fish, birds and other wildlife. Keep out of any body of water. Do not contaminate water by cleaning equipment or disposal of wastes.

USE DIRECTIONS

It is a violation of Federal law to use this product in a manner inconsistent with its labeling. D-Plus Dust insecticide is a ready-to-use insecticidal dust which controls pests as indicated below. Apply directly into cracks and crevices or other localized areas with a bulbous duster or other suitable equipment. The amount of D-Plus Dust to be applied will vary, but should usually be in the range of ½ to 4 ounces per square yard.

Application Within Residential Buildings Including Homes and Apartment Buildings and Within Non-food Areas of Institutional, Institutional, and Commercial Buildings Including Hospitals, Stores, Manufacturing Plants and Warehouses. For Spot Treatment Only - Apply a light but uniform dust to all calared areas where cockroaches, (including strains resistant to certain other insecticides), ants, clover mites, crickets, firebrats, silverfish and spiders are found or normally occur including dark corners of rooms and closets, cracks and crevices in walls along and behind baseboards, beneath and behind sinks, stoves, refrigerators and cabinets, around plumbing and other utility installations. For ants apply to ant trails, also around doors and windows and wherever else these pests may find entrance. For control of American and Banded Brown cockroaches in little areas, apply as a light but uniform dust at a rate of 1 to 2 ounces per sq. yd. in unoccupied spaces. For control of carpet beetles apply dust as a spot treatment along baseboards and edges of carpeting, under carpeting, rugs and furniture. In closets and on shelving and wherever else these insects are seen or suspected. For control of ticks and fleas, apply dust as a spot treatment to infested areas such as pet beds and resting quarters, nearby cracks and crevices, along and behind baseboards, window and door frames and localized areas of floor and floor covering where these pests may be present. Old bedding of pets should be removed and replaced with fresh, clean bedding after treatment. DO NOT TREAT PETS WITH THIS PRODUCT. To control the source of flea infestation, pets inhabiting the treated premises should be treated with a product registered for application to animals.

Comments: Apply dust around doors and windows and other places where ants enter premises and where they crawl or hide. Also force dust into cracks and crevices or through openings or small newly drilled holes into wall voids where ants and/or nests are present. Use a sufficient amount to lightly cover area surfaces. **Wasps, Bees and Hornets:** Apply on nest and surrounding area. To treat nests in wall voids (drill a hole in the wall, blow in dust and re-seal. Do not use this product to treat overhead nests.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal. **STORAGE:** Store product in its original labeled container in a cool, dry, locked place out of reach of children. **DISPOSAL:** Do not reuse empty container. Wrap and put in trash.
