**PERENNIAL WEEDS**(Partial Listing)-Bahagrass, Bermudagrass, Bull Thistle, Canada Thistle, Centipedegrass, Clover, Creeping Charlie, Beggartick, Dock, Dandelion, Dogfennel, Field Bindweed, Johnsongrass, Kentucky Bluegrass, Nimblewill, Nutgrass, Orchardgrass, Poison Ivy, Poison Oak, Ragweed, Plantain, Spurge, Fescuegrass.

**IMPORTANT:** This product kill all green plant tissue. When treating weeds do not allow spray to touch surrounding desirable plants, grasses, flowers and/or shrubs. Wash spray off immediately with plenty of water. Weed kill will be reduced if it rains on treated area within 24 hours after treatment. Retreat as soon as possible.

**HOW MUCH TO USE:** This product is ready to use. Spray each weed to point of spray run-off. One gallon should treat approximately 1800 Sq.Ft. (equal to 1 lb. active ingredient per acre).

**WHEN TO USE:** Apply when weeds are actively growing at any time of the year. Most weeds begin to die within 5 to 7 days with complete kill in 2 to 4 wks.

**HOW TO APPLY:** Apply with hand sprayer or sprinkler to give coarse droplet spray coverage. Apply directly to the center of weed growth. One treatment will kill most weeds listed. Repeat treatment within 3 to 4 weeks if "Hard-To-Kill" perennials persist.

**RESEEDING THE LAWN AREA:** Areas that have been treated can be seeded within 7 days of treatment. This product has no residual weed control effects.
