Ants, Sametter Bugs, Brown Dag Ticks, Chiggers, Clover Mites, Cockreaches, Crickets, Earwes, Fless, Files, Millipedes, Soubugs (Pillbugs), Spiders, and Springlaite (Collembole).

Dear Mr. Boyd:

The amendments referred to above, submitted in connection with registrations under the Federal Insecticide, Funcicide, and Rodenticide Act, are acceptable provided the following revision is made to each label prior to release for shipment under the amended labeling:

1) The Environmental Hazards section for both of these products should be revised to more accurately reflect wildlife exposure from limited home foundation area treatment (comments about birds feeding on treated areas, and about shrimp and crab as resources are to be deleted). Specifically, revise the Environmental Bazards text to read as follows:

This pesticide is highly toxic to birds, fish, and other wildlife, including waterfowl. Keep out of lakes, streams, ponds, tidal marshes, and estuaries. Do not apply directly to water or wetlands (swamps, bogs, marshes, and potholes). Do not contaminate water by disposal.

This pesticide is highly toxic to bees exposed to direct treatment or to residues on blooming plants where they feed. Do not allow this pesticide to drift to blooming plants, if bees are visiting the treatment area. Do not amply this product to or allow it to drift to food crops or any desirable vegetation at any time.

A stamped copy of each label is enclosed for your records. Please submit five (5) copies of the revised amended label for each of the subject products prior to release for shipment under the amended labeling.

Please refer to the Diazinon Registration Standard, as amended, for release for shipment and channels of trade dates for diazinon products bearing appropriately amended labels.
