Shake Well Before Use

To operate hold can upright, direct orifice toward the surface to be treated and press the actuator button. \Box

To-kill ants, carpet beetles, centipedes, cockroaches, crickets, earwigs, firebrats, pillbugs, silverfish and spiders: Thoroughly apply as a spot treatment to areas where these pests are found or may hide, including dark corners of rooms and closets, cracks and crevices, under carpets, along baseboards and door sills and frames; benind and beneath sinks, stoves, refrigerators, cabinets and around garbage cans, plumbing and other utility installations. Pests driven out of hiding places should be sprayed directly. Spray ant trails, nests and points of entry.

To kill brown dog ticks: Apply thoroughly as a spot treatment to infested areas such as pet beds and resting quarters, and nearby cracks and crevices; along and behind base-boards, window and door frames and localized areas of floor and flc r covering where these pests may be present. Fresh bedding should be placed in animal quarters following treatment. Do not spray pets with this product.

To control houseflies, gnats, hornets, mosquitoes, small flying moths, wasps and yellow jackets: Use only on outdoor surfaces. Spray outside surfaces of window and door frames and other areas where these pests may enter the home. Also spray dark corners and localized resting areas, such as under eaves, porches, partitions and in garages where these insects may congregate. Flies and mosquitoes coming to rest on treated surfaces will be killed. Repeat treatment when effectiveness diminishes.

Application of this product in the food areas of food handling establishments other than as a spot and/or crack and crevice treatment is not permitted.

Application within food handling establishments: [Places other than private residences in which exposed food is held, processed, prepared or served including, but not limited to, areas for receiving, storage, packing (canning, bottling, wrapping, boxing), preparing foods, edible waste storage and enclosed processing systems (mills dairies, edible oils, syrups) and serving areas (when food is exposed and facility is in operation): Use as a crack and crevice treatment in and around both food and nonfood areas to control ants, cockroaches, crickets, silverfish, spiders and waterbugs. Apply in small amounts directly into cracks and crevices, delivering a pin stream of insecticide in points between different elements of construction, between equipment and floor, openings leading to voids and hollow spaces in walls, equipment legs and bases, in conduits, motor housing, junction or switch boxes. Application within food serving area (facilities where foods are served, such as dining rooms, but excluding areas where food may be prepared or held): Apply as a spot treat(nt to selected surfaces, such as baseboards, under elements of construction and into cracks and crevices.
