

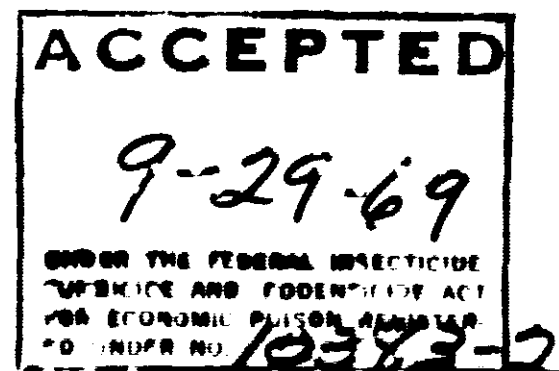
GENERAL INFORMATION:

WECO WEED KILLER 111 is a specially formulated nonselective vegetation killer. Apply undiluted as a spray only where total weed kill is desired. WECO 111 has no harmful residual activity in soil at recommended rates. It is an aqueous contact weed killer specially prepared for municipal and industrial weed control.

DESCRIPTION OF PRODUCT:

WECO WEED KILLER 111 is a nonvolatile, nonexplosive, nonflammable aqueous formulation. It is essentially noncorrosive. It exhibits a very rapid action on aerial parts of plants. Under sunny-warm conditions the first symptoms can be observed within one to two hours, severe wilting after 24 hours.

RECOMMENDATION FOR USE:

For good contact weed control apply WECO 111 at the rate of 2 qts. per 100 sq. ft. For larger areas, apply the product at 5 gals. per 1000 sq. ft. or 200 gals. per acre. Good wetting is necessary for best results. Application may be made at any time during the growing season. Early application produces better results. Repeat applications should be made to control some perennials and late germinating annuals. Apply WECO 111 as a directed spray for the control of weeds at the base of trees, shrubs, vines, hedge plants. Avoid spray contact of the foliage of desirable plants. Use hand sprinkler, hand sprayer or machine sprayer.

DO NOT APPLY: Do not allow spray to contact foliage or stems of desirable plants. Do not allow spray to contact desirable lawn grasses.
