DIRECTIONS FOR USE

For crabgrass control only: Apply 220 pounds per acre or one fifty (50) pound bag to 10,000 square feet (100 x 100) of turf area during the spring of the year prior to the germination of crabgrass. At this rate of application one ton of LAKESHORE'S TURF FERTILIZER with BALAN™ will cover 9.1 acres which supplies a minimum of 1.5 pounds of Technical Balan per acre and approximately 0.7 pounds of nitrogen per 1,000 square feet. Do not reseed the treated area for six (6) weeks after application.

For poa annual control: Apply at the rate of 275 pounds per acre or one fifty (50) pound bag to 8,000 square feet (80 x 100) of turf area during the early spring (prior to May 15) or during the summer period of July 15-August 15. At this rate of application one ton of LAKESHORE'S TURF FERTILIZER with BALAN™ will cover 7.3 acres which supplies a minimum of 2.0 pounds of Technical Balan per acre and 0.9 pounds of nitrogen per 1,000 square feet. Do not reseed the treated area for 12 to 15 weeks.

In order to assure the desired results, it is suggested that the product be applied evenly to the turf area at the recommended rate. Avoid excessive or inadequate application. The product has a bulk density of approximately sixty (60) pounds per cubic foot.

LAKESHORE'S TURF FERTILIZER with BALAN™ is a combination of a quality fertilizer and a selective pre-emergence herbicide which controls smooth and hairy crabgrass, annual blue grass (poa annua), green and yellow foxtail, barnyard grass, and goosegrass (silver crabgrass or crowfoot) by destroying the infant plants as the seeds germinate. It does not control established weeds.

LAKESHORE'S TURF FERTILIZER with BALAN™ can be applied to established turf grasses of bluegrass, ryegrass, fescue, zoysia and bermuda and will not result in any injury to the turf when applied in accordance with the directions. Do not apply to bent grass, dicandra or newly planted areas of bermuda, St. Augustine or centipede grasses. Do not apply to any lawn seeded the previous fall season.
