Spread evenly at a rate of 1 pound per 1,000 square feet. After application, water lawn using 30 gallons per 1,000 square feet. To help obtain uniform distribution, apply one half the required amount in one direction; then apply the balance at a right angle.

To control ANTS, BROWN DOG TICKS, CRICKETS, CUTWORMS, EARWIGS, SOD WEBWORMS, CHINCHBUGS and SOWBUGS—spread uniformly at a rate of 1 pound per 1,000 sq. ft. in northeastern states; make first application in May or June or when insects first appear. Re-treat as needed, usually in July or August.

NOTE: To reduce initial infestation or reinfestation of buildings by Earwigs, treat a band of ground 6 to 10 feet wide around and adjacent to the buildings where these pests are active.

To control HYPERODES WEEVILS-apply as above except at twice the rate of two pounds per 1,000 square feet. Apply over suspected problem area in mid-April and again in mid-May.

To control WHITE GRUBS (larvae of Japanese Beetle and European Chater), use 4 pounds per 1,000 square feet. Apply the granules uniformly over the area treated followed immedately by thorough watering to wash the insecticide into the furf. For best results, treat when grubs are young and actively feeding near the soil surface, usually during late July and August Consult your local agricultural extension service specialist for proper time to treat in your area.
