USE AND APPLICATION

Spread evenly at a rate of 1 pound per 1,000 square feet. To help obtain uniform distribution, apply one half the required amount in one direction; then apply the balance at a right angle.

To control ANTS, BROWN DOG TICKS, CRICKETS, CUTWORMS, EARWIGS, SOD WEBWORMS, CHINCHBUGS and SOWBUGS - spread uniformly at a rate of 1 pound per 1,000 square feet; in northeastern states, make first application in May or June or when insects first appear. Re-treat as needed, usually in July or August.

NOTE: To reduce initial infestation or reinfestation of buildings at industrial plant sites only by Earwigs, treat a band of ground 6 to 10 feet wide around and adjacent to the buildings where these pests are active.
