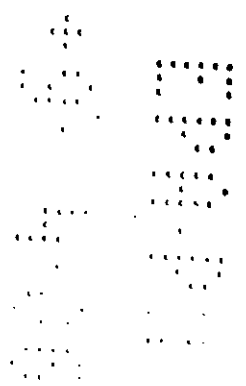

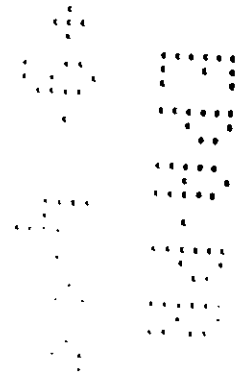
DIRECTIONS FOR USE
