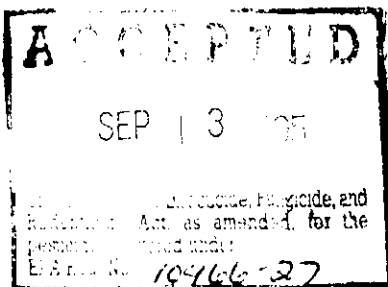

DIRECTIONS FOR USE

UltraFresh® NM is an additive designed for application to textiles at 1-4% on weight of goods to inhibit the growth of odor-causing bacteria on these surfaces.

The duration of UltraFresh® NM's bacteriostatic activity has been experimentally demonstrated on washable treated fabrics subjected to 50 conventional launderings.

UltraFresh® NM is also used as a laundry additive, for rugs and carpets application, and upholstery additive. Please consult the respective product information sheet for application parameters.

PRECAUTIONARY STATEMENT:

Harmful if swallowed. Avoid contact with eyes, skin or clothing.

STATEMENT OF PRACTICAL TREATMENT

In case of contact, immediately flush eyes or skin with plenty of water for at least 15 minutes. For eyes, call a physician. Remove and wash contaminated clothing before re-use. If swallowed, drink promptly a large quantity of milk, egg whites, gelatin solution or, if these are not available, drink large quantities of water. Avoid alcohol. Call a physician immediately.

STORAGE & DISPOSAL

Storage: Store in a well ventilated place and keep away from light. Keep tightly closed until ready to use and reclose tightly after each use.

Pesticide Disposal: Waste resulting from the use of this product may be disposed of on site or at an approved waste disposal facility.

Container Disposal

Metal Containers: Triple rinse (or equivalent). Then offer for recycling or reconditioning or puncture and dispose of in a sanitary landfill or by other procedures approved by state and local authorities.

Plastic Containers: Triple rinse (or equivalent). Then offer for recycling or reconditioning or puncture and dispose of in a sanitary landfill, or by incineration, or, if allowed by state and local authorities, by burning. If burned, stay out of smoke.

General: Consult Federal, state or local disposal authorities for approved alternative procedures. Do not use or store near heat or open flame.
