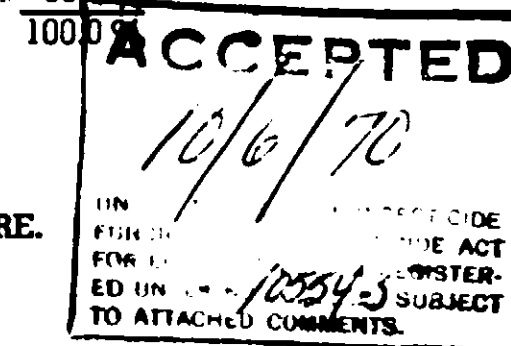

DIRECTIONS FOR USE:

Di-Syston is a systemic insecticide that enters the plant through the root system. The insecticide, when placed or washed into the soil so as to reach the roots, is picked up and moved in the sap stream to all parts of the plant where it kills insects as they feed on the plant. The plant will also absorb Di-Syston through contact with the foliage surface.

IMPORTANT: Moisture as rainfall or irrigation should follow within 10 days if possible after application for maximum results.

SORGHUM: Apply _____ pounds per acre (1 lb. actual insecticide) as a soil treatment. Do not apply more than once per crop season nor within 30 days of harvest for grain or 14 days of harvest for forage and fodder. Read **IMPORTANT** statement above.
