- 1) Correct the spelling at the end of the chemical name for the active ingredient to read "...pyrazinediium...".
- 2) Add a referral statement to the front panel to refer users to precautionary statements elsewhere on the labeling. The statement should appear immediately after the signal word and "KEEP OUT OF REACH OF CHILDREN" statement.
- 3) Correct the typographical error appearing at the end of the Storage statement to read "...from heat or open flame."
- 4) Revise the disposal statements to read as follows:

"PRODUCT DISPOSAL: Securely wrap in several layers of newspaper and discard in trash."
