This product is designed primarily for spot control of perennial (year round) weeds in growing Bermudagrass lawns as well as in ground cover such as Lippia and Rosemary. This product is a selective systemic: it can kill top growth and the roots of perennial (year round) weeds such as; Nut Grass, Perennial Rye, Wild Carrot, Oxalis, Crab Grass, and Poa Annua (Blue Grass) in one or more applications without killing Bermudagrass Lawns. It is also designed to kill tough woody perennial such as Salt Bush, Desert Broom, and Tumble Weed, as well as Ragweed and White Horse Nettle.

HOW TO APPLY: Spray directly on the foliage (leaves) of the weed until wet. It is not necessary to soak. When sprayed on the green foliage of a weed, this herbicide will move to the root system and destroy it. Much foliar (leafy) area is needed for it to be absorbed, therefore allow the weed to grow at least 3-5 inches before spraying.

Spray the entire weed until wet. The next day hose down with plenty of water all treated plants. Three to five days later weeds will show stress and start to dry and brown out. Annual (seasonal) weeds and grasses are now destroyed. Perennials, though, will require re-treatment. Re-spray any part of the plant that remains green after five days and again when green reappears in about three weeks. Good control can be established within one growing season, but complete eradication may take two or more seasons. When using this material on a tough woody perennial it will be necessary to spray the weed more than once. After the first application, when any growth shows through dead patches, reapply until the weed has fully absorbed the herbicide into its root system and is dead. When Spot spraying in Bermudagrass lawn and ground cover, slight brown spotting may appear, especially in hot weather. This is temporary, though, and will disappear with new growth. 'fh:s material will cause brown spots in St. Augustine lawns and in Dichondra. Test a small area before using.
