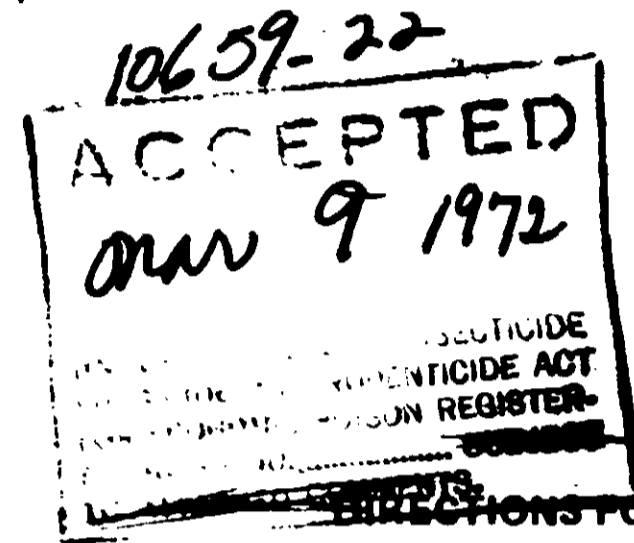
TREATMENT: In case of poisoning, call a physician immediately. Have patient lie down and keep quiet. If swallowed induce vomiting by giving a tablespoon of salt in a glass of warm water. Administer milk or water freely and again induce vomiting until vomit fluid is clear. If on skin, remove contaminated clothing and wash skin immediately with soap and warm water. If eyes are contaminated, wash with flowing water for at least 15 minutes.
