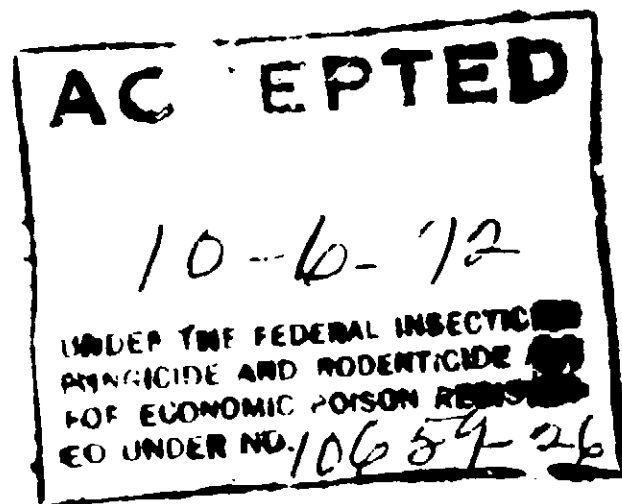

DIRECTIONS FOR USE:

whole potato tubers
OXY-TREET 6% is a special fungicide dust formulation for application to whole or cut potato tubers for the control of Fusarium seed-piece decay and seed-borne common scab.

Use one (1) pound of OXY-TREET 6% per 100 pounds of whole or cut potato seed pieces. Apply the dust so that the entire surface of the seed piece is thoroughly covered by the fungicide dust. Treated seed may be held for one (1) week (slightly longer) at cool temperature and high relative humidity to promote suberization or the seed may be planted immediately. DO NOT USE TREATED SEED POTATOES FOR FOOD OR FEED PURPOSES.
