DIRECTIONS FOR USE

(Do not apply this product for any uses other than those specified on the label.)

ZIPP 15-5-10 is a complete turffood containing sulfur, magnesium, from and zinc in addition to the printary nutrients formulated in a manner that promotes optimum turf nutrition for a longer period of time than that obtained from conventional fertilizers.

For uniform application set spreader for ½ the recommended rate and apply one half the total amount over the area to be treated, moving in one direction at a steady rate. Spread the remaining half quantity over the same area, this time moving at right angles to the first application. This product may be used on such turf species as St. Augustine. bahia, bent, Bermuda, centipede and Zoysia. Under conditions of adequate moisture, high temperatures and high humidity, over application may cause some short-lived discoloration of the St. Augustine.

WHEN TO APPLY: For optimum weed control, application should be made when weeds are growing vigorously. Application can be made at any time, however, for maximum safety to the St. Augustine, make application during spring and fall when temperatures are moderate.

AMOUNT TO USE: Apply 50 pounds per 3,000 square feet. Make application when grass blades are dry. CHECK SPREADER FREQUENTLY TO BE SURE THE RECOMMENDED RATE IS BEING APPLIED. For best weed killing results do not mow, rake or water the lawn for at least 24 hours after application. Lawns which are in poor condition (badly infested with weeds) may require a second application of this product. It is suggested this be done one month after the first.
