DIRECTIONS

PENTRA-FOG INSECT SPRAY is a contact insecticide which incorporates pyrethrum and synergist in a highly refined petroleum distillate base. PENTRA-FOG is formulated as an industrial, institutional, or municipal control for roaches, silverfish, bed bugs, flies, mosquitoes, and certain other insects in their accessible stages. For best results, PENTRA-FOG should be used with electric sprayers, but hand or compressed air sprayers may be used.

FOR ROACHES, SILVERFISH, and certain other crawling insects: Spray thoroughly, contacting as many insects as possible. Direct spray to penetrate all cracks, crevices, and hiding places. Spray around sinks, shelves, refrigerators, machines, and food storage areas. For normal conditions, spray once a week. For heavy infestations, spray daily. During summer months, it is advisable to spray twice a week.

FOR BED BUGS: Spray mattress and bed thoroughly, as well as baseboards and wall cracks and crevices around the room. Spray whenever insects are evidenced.

FOR FLIES AND MOSQUITOES: Before spraying close all doors and windows. Spray room thoroughly, directing the spray towards the ceiling so as to fill the room with a fine mist. After 10 to 20 minutes sweep up and destroy all fallen insects. Repeat spraying as often as necessary.

CAUTION: PENTRA-FOG is a combustible mixture; do not spray near open flame or store near heat.

Harmful if swallowed.

Stay out of treated rooms or buildings until they are thoroughly aired. After spraying, thoroughly clean all surfaces to be used for food preparation. Remove birds, pets, and fish bowls before spraying.

Use PENTRA-FOG as a space spray in food processing plants only when plant is not in operation. Foods should be removed or covered during treatment. All food processing surfaces should be covered or thoroughly cleaned before using.

NOTICE

KEEP FROM FREEZING. If this product is stored in cold or freezing weather it may separate or thicken. This will not harm the performance. Before using, warm to room temperature and stir thoroughly.
