DIRECTIONS

Excellent for cleaning and deodorizing toilets and urinals. For disinfecting urinals, bathroom fixtures, showers and porcelain, use 6 oz. to a quart of water. With this product wet the surfaces to be cleaned thoroughly and let stand for 10 minutes. Then scrub and rinse with clean water.

Empty toilet of all water before pouring bowl cleaner in. For cleaning urinals and toilets, pour 4 to 6 oz. directly into bowl and let stand for a few minutes. Then swab sides and below water line with a bowl mop.

SWIMMING POOL SURFACES: This product will remove soap film, scum, mildew stain and certain mineral deposits. Apply to walls, gutters and floors at full strength. Let stand for 10 minutes. Then dilute product 3 to 1 with water and scrub area to be cleaned with a bristle brush. Wear rubber gloves and protect eyes when applying in this manner. Rinse empty container with water and discard it. For mildew stain removal repeat application weekly as necessary to maintain control.

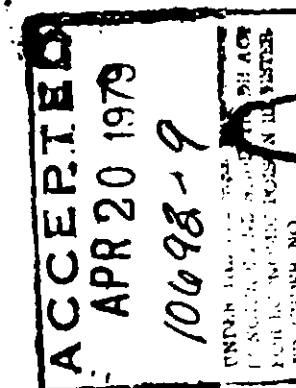
