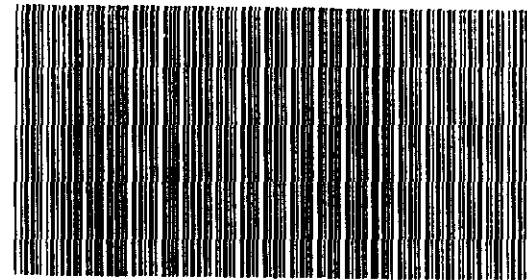

PRECAUTIONARY STATEMENTS

HAZARDS TO HUMANS AND DOMESTIC ANIMALS

STATEMENT OF PRACTICAL TREATMENT

In case of contact, immediately flush eyes or skin with plenty of water for at least 15 minutes. For eyes, call a physician. Remove and wash contaminated clothing before reuse. If swallowed, drink promptly a large quantity of egg whites, gelatin solution or, if these are not available, drink large quantities of water. Avoid alcohol. Call a physician immediately.

X-CIDE 105 Industrial Bactericide will control bacteria found in waters associated with petroleum production. It will control bacteria in water which collects in tank bottoms, in water for flooding operations, in water disposal systems, gas transmission and completion of fluids.

X-CIDE 105 Industrial Bactericide may be applied in systems used to treat injection water immediately ahead of water deoiling equipment, in the clear water holding tank, or at the suction side of the injection pump.

X-CIDE 105 Industrial Bactericide should be used full strength in concentrations of 15 ppm of X-CIDE 105 Industrial Bactericide on a continuous basis or in slug applications up to 250 ppm of X-CIDE 105 Industrial Bactericide as often as needed (1/8 pint per 1000 gallons equals approximately 15 ppm). A typical slug application is 1/2 pint per 1000 gallons.

STORAGE AND DISPOSAL

STORAGE: Do not contaminate water, food or feed by storage or disposal. Do not use, pour, spill or store near heat or open flame.
