Dear Mr. Siegel:

The amended label referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act as amended is acceptable provided the following changes are made:

1. Line up the numbers in the ingredients statement
2. Place the statement "Keep out of reach of children" above the signal word "Danger"
3. In the "Directions for Use" section there is a reference to "Instant Power Root Destroyer". However, on the top of the first page it only states "Root Destroyer". If you are making a name change, you need to request this change so the Agency's records can be amended. If the name is not being changed, the correct product name must be referenced throughout the label.
4. Place the "Storage and Disposal" section above the "Notice to Buyer".

One copy of the label stamped "Accepted with comments" is enclosed for your records. Please submit one copy of the final printed label that incorporates the required changes before the product is released for shipment.
